**Item 1: Student Liaisons**

- Association is looking to hire an additional student liaison as Ms. Kim is slated to graduate in the Spring
  - Ms. Kim has read one application thus far, and will forward to Mr. Lee and Ms. Li for further evaluation
    - Ms. Kim reported that the candidate is currently a sophomore who appears to be both responsible and a competent writer
  - Mr. Lee asked Ms. Kim to coordinate an interview of the candidate with Ms. Borst (and most probably one other Association figure)
- Mr. Lee instructed Ms. Kim to accept any late applications, though indicated that the process should be finalized by the year's end.

**Item 2: Alumni Fair**

- Scheduled for Thursday, February 17
- Mses. Kim & Li have reserved an event room from 5:00 – 9:00 PM
  - Mr. Lee indicated that the event should run from 7:00 – 9:00 PM
  - Event structure will feature two panel sessions separated by a break, followed by a period for mingling/informal questions
    - Mses. Kim & Li will serve as the panel moderators
  - Mr. Lee requested that Mses. Kim & Li ask the school's main office about necessary logistics surrounding the event: setting up, cleaning afterward, and potentiality of both food and security
- Mr. Lee requested that Ms. Kim contact a PTSA board member who last year offered to help with the event and apprise her of its date
- Current event panelists include a dendrologist, medical student, business student, lawyer and nurse
  - Association is seeking an engineer to join the panel

**Item 3: Reunion and Hand-outs**

- Ms. Long is coordinating the class of 2000's 10 year reunion, set for Friday November 26
- One aim for the reunion is for the Association to increase its visibility amongst alumni, as well as glean class of 2000-specific information
- Ms. Li printed out double-sided info cards, half of which are to be conveyed to Ms. Long in advance of the reunion for distribution at the event
